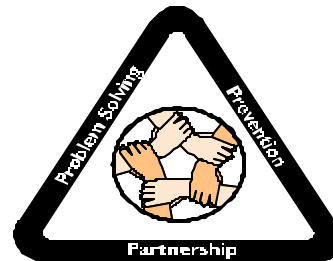

## Information about Denver TRIAD

### What is TRIAD?

When the Denver TRIAD program began it consisted of a three way effort among the Denver Police Department, Denver District Attorney's Office and Seniors who agreed to work together. Their primary goals were to reduce the criminal victimization of older citizens and enhance the delivery of law enforcement services to the Denver's Senior population.

Denver TRIAD has grown to develop several partnerships within the Senior community. TRIAD's new focus is to become a 311 (Information Outreach Resource) to Denver's Senior community.

### What Can TRIAD Do?

Denver TRIAD assesses the needs of a particular community through the assistance of Denver Police Community Resource Officer's.

TRIAD offers various types of outreach services to the Senior community such as free presentations offered by the TRIAD partners. Topics include crime prevention, victim's assistance, current fraud trends, elder abuse prevention,
