Graffiti vandalism is illegal (DRMC 10-176). Its continued presence creates community blight and is encouraged to be removed as soon as possible. You can help keep Denver graffiti free by authorizing the City to remove graffiti from your property free of charge.

CHECK ONE OF THE BOXES BELOW TO ACCEPT OR DECLINE FREE GRAFFITI ABATEMENT SERVICES OFFERED BY THE CITY & COUNTY OF DENVER

_____ I authorize the City and County of Denver (employees or contractors) **and** any volunteer group approved by the City to attempt to remove unlawful and unwanted graffiti from my property **without charge** using available methods and equipment. **This property currently has graffiti (check one) yes _____ no _____**

NOTE: As the owner/responsible party, you remain responsible for requesting graffiti-removal assistance or removing the graffiti from this property each time it appears.

NOTE: If this box is checked, you must have the graffiti vandalism removed from this property within 48 hours (non-residential property) or 72 hours (residential property) following notification.

NOTE: If this box is checked, the City will be unable to provide abatement assistance at this location AND you will be responsible for the removal of all other unauthorized graffiti vandalism from this property within 48 hours (non-residential property) or 72 hours (residential property) following notification.

NOTE: When authorizing graffiti removal, the owner or responsible party understands that the City and County of Denver or its contractor does not guarantee the structural or aesthetic soundness of the areas from which graffiti will be removed and that even in the exercise of due care, damage or injury to real or personal property may result from this activity. I hereby agree to indemnify and hold harmless the City and County of Denver, their officers, agents, employees, and servants, from and against any and all claims, liability, expense, including defense costs and legal fees, and claims for damage of any nature whatsoever, including but not limited to bodily injury, death, personal injury, or property damage arising from or connected with the City and County of Denver's graffiti removal activities.

This document will remain in effect until modified or terminated by the property owner, his or her representative, or the City. Notification shall be in writing. I have read the above and understand it.
