THE COMMISSION HEREBY AFFIRMS the following was accomplished in full compliance with the requirements of Commission Rule 2, Section 4(A), Rule Making:

Publishing on March 17, 2006, a Notice of Public Hearing – Rule Making regarding proposed changes to Commission Rule 3 § 1B, 1C & 1D, along with the full text of the proposed sections;

Posting said Notice and the full text of the proposed rule changes from March 17, 2006 through April 14, 2006, at the Commission's office and on the Commission's web site;

Forwarding on March 21, 2006, said Notice and full text of the proposed rule change to the Manager of Safety, the collective bargaining agents for members of the Classified Service, interested parties; and to the administration of the Fire and Police Departments (with a request for posting throughout the departments);

Conducting on April 14, 2006, a public hearing on the proposed rule changes;

FURTHER, on April 14, 2006, subsequent to the public hearing, the Commission unanimously approved for subsequent adoption the proposed changes to Rule 5 § 4(E) as posted and published.

APPROVED CHANGE TO RULE 5 § 4(E)
Approved April 14, 2006 for Adoption as Posted

E. Failure of Any Phase of the Examination or Screening Process:
(Adopted September 1, 2004)

1. Except as provided in this Rule 5 § 4(E)(2), failure of any test phase of the examination designated by the Commission as pass/fail, or failure to achieve a passing score on any scored test phase with a set passing point, shall disqualify the applicant for original appointment from further participation in the examination process and/or screening process.

2. In the case of any Physical Ability Test, an applicant who fails the test may be provided a second opportunity to pass the test when the respective Examination Announcement stipulates specific regulations governing the administration of, and eligibility for, any such retest. However, in no circumstance shall an individual who has failed the Physical Ability Test be permitted to proceed in the respective examination and/or screening process until such time as he/she has passed the Physical Ability Test.

3. A failure to successfully complete any phase in the screening process shall also disqualify the applicant from further participation in the examination process, screening process, placement on the eligible register, and/or from original appointment to the rank in question, as applicable.
