# GRAFFITI VANDALISM REMOVAL FORM

*Graffiti vandalism is illegal in Denver. Help keep Denver graffiti-free by authorizing the City to remove graffiti from your property free of charge!*

## CHECK BELOW TO ACCEPT OR DECLINE FREE GRAFFITI REMOVAL SERVICES OFFERED BY THE CITY OF DENVER

\_\_\_\_ I authorize the City and County of Denver (employees or contractors) and any volunteer group approved by the City to attempt to remove unlawful and unwanted graffiti from my property without charge using available methods and equipment.

This document will remain in effect until modified or terminated by the property owner, his or her representative, or the City. Notification shall be in writing.
