THE COMMISSION HEREBY AFFIRMS that on June 11, 2020, the Commission "all five members present" unanimously approved for adoption the proposed amendments to Rules 1, 5, and 12 as published and posted on April 27, 2020. The proposed amendment to Rule 3 was passed by a vote of 3-2 as published and posted on April 27th, 2020. - Forwarding on April 27, 2020, the *Notice of Public Hearing – Rule Making* and the full text of the proposed amendments to Rules 1, 3, 5 and 12 to the Executive Director of Safety, to the representatives of the collective bargaining agents for members of the Classified service, and to interested parties; and to the administration of the Fire and Police Departments with a request for posting.
