**AFFIDAVIT**

For the City and County of Denver as Proof of Lawful Presence  
in the United States

I, Applicant, swear or affirm under penalty of perjury under the laws of the State of Colorado the following:

1. I am over eighteen years of age and am competent to make this Affidavit.
2. I swear or affirm that (check one):

I am an alien lawfully present in the United States pursuant to Federal law.

3. I understand that this sworn statement is required by law because I have applied for a public benefit in the form of a City and County of Denver Fire Safety Systems License. I understand that state law requires me to provide proof that I am lawfully present in the United States prior to receipt of this public benefit. I further acknowledge that making a false, fictitious, or fraudulent statement or representation in this sworn affidavit is punishable under the criminal laws of Colorado as perjury in the second degree under Colorado Revised Statutes §18.8-503 and it shall constitute a separate criminal offense each time a public benefit is fraudulently received.
