**\*PERMISSION TO RIDE WILL NOT BE GIVEN TO PERSONS UNDER 18 YEAR OF AGE**

APPROPRIATE ATTIRE MUST BE WORN. CLOTHING MUST BE CLEAN AND IN GOOD CONDITION. SKIRTS ARE NOT ALLOWED, AS FIREFIGHTER PANTS MUST BE WORN AT FIRE INCIDENTS. FIRE OR PARAMEDIC SERVICE EMPLOYEES MAY WEAR THEIR UNIFORMS. THE COMPANY OFFICER MAY CANCEL PERMISSION TO RIDE BASED UPON THE APPEARANCE OF THE GUEST RIDER. THE DEPARTMENT WILL PROVIDE PROTECTIVE EQUIPMENT (HELMET, COAT, ETC.)

ALL SAFETY RULES, AS OUTLINED BY THE OPERATIONS DIVISION AND COMPANY OFFICER MUST BE FOLLOWED. FAILURE TO COMPLY WILL BE CAUSE FOR TERMINATION OF THE REMAINDER OF THE VISIT.

For exchange for being granted the privilege to ride as an observer on a Denver fire apparatus, I release the City and County of Denver, the Denver Fire Department, its Officers, agents and employees from (1) any personal injury which may occur, (2) any damage to my clothing or personal property, (3) any other loss or damage which may occur, which results from the negligent acts of any person. Any person includes, but is not limited myself, all employees of the City and County of Denver, including Denver Fire Officers and persons with whom the Denver Fire Officer may have contact. I intend this release of liability to cover all situations that may occur while I accompany the Denver Fire Officer(s). I realize that accompanying Fire Officers on their tour of duty may expose me to hazardous situations. Such potential hazards can include, but are not limited to, all types of emergencies, forms of physical violence, explosions, falls, dog bites, and motor vehicle accidents. I agree to assume the risk of any personal injury, loss or damage that may result from any hazardous situation to which I am exposed. I agree to act as my own insurer against all hazards and negligent acts of any person. I agree to hold harmless and indemnify the City and County of Denver, the Denver Fire Department, its officers, agents and employees from any liability, which may be asserted against them for any act, which I may commit while I accompany the Denver Fire Officers on their tour of duty. "I agree to keep strictly confidential any health information of individuals that I learn of or observe during, or as a result of, my ride."

(If a court of law construes that any part of this release is invalid, such construction shall not invalidate the remainder of this release.)
