



*7. State of Emergency Declaration		
<p>WHEREAS, people are at risk from a novel coronavirus, now designated COVID-19 in the City and County of Denver;</p> <p>WHEREAS, the risks posed by this natural threat require early warning for, and preparation by, those potentially or actually affected; as well as prompt coordination of response and recovery actions, or special regulations of access, activities, persons, property, or the environment in order to protect the health, safety, or welfare of people, to limit damage to property, or the environment within the City and County of Denver;</p> <p>I HEREBY DECLARE, pursuant to the State Constitution, the Colorado Disaster Emergency Act (C.R.S. § 24-33.5-701, <i>et seq.</i>), the Charter and Ordinances of the City and County of Denver, and Chapter 16 of the Denver Revised Municipal Code that a STATE OF LOCAL DISASTER EMERGENCY in and for the City and County of Denver now exists and is so ordered, authorized, and approved.</p> <p>BE IT KNOWN THAT the geographic area affected and to which this DECLARATION applies is known as the City and County of Denver, Colorado.</p> <p>AND BE IT ALSO KNOWN THAT the Mayor of the City and County of Denver hereby advises the Governor of the State of Colorado and the population within the City and County of Denver that a STATE OF LOCAL DISASTER EMERGENCY exists and that the Mayor of the City and County of Denver may exercise some or all of the powers allowed by the State Constitution, the Colorado Disaster Emergency Act (C.R.S. § 24-33.5-701, <i>et seq.</i>), the Charter and Ordinances of the City and County of Denver, and Chapter 16 of the Denver Revised Municipal Code during this STATE OF LOCAL DISASTER EMERGENCY.</p> <p>AND BE IT ALSO KNOWN THAT this DECLARATION authorizes the City and County of Denver, its residents, and its businesses to apply for assistance from the State of Colorado, the Federal Government, or other available resources.</p> <p>AND BE IT ALSO KNOWN THAT this DECLARATION and STATE OF LOCAL DISASTER EMERGENCY will remain in force from March 12, 2020 to March 19, 2020. This DECLARATION will remain in effect for 7 days unless renewed or rescinded.</p>
