No Patron dancing permitted.</p> <p>Dance Cabaret – Live or recorded entertainment and patron dancing, no adult entertainment.</p> <p>Special Dance Cabaret – Live or recorded entertainment and patron dancing is permitted. Entertainment is confined to the interior of the building or located upon the licensed premises as defined in the Colorado Liquor Code. Unamplified live entertainment or recorded entertainment and patron dancing may be provided beyond the interior of the building before 8:00 p.m.</p> <p>Event Center Cabaret – Seating capacity of at least 2,000 in which both live and/or recorded entertainment is provided and in which patron dancing is permitted.</p> <p>Adult Cabaret – Adult entertainment is provided, as well as the entertainment included in the Dance Cabaret.</p>
