A vehicle endorsement allows a Private Security Employer to authorize their security guards to use vehicles during the performance of security services. A vehicle endorsement is required whether the vehicles to be used are owned by the employer, the guards, or another entity.

**SECTION II - VEHICLE ENDORSEMENT REQUIREMENTS**

**DEFINITION OF A VEHICLE DESIGN**

A vehicle design mean a distinct set of verbiage, font, decal, and/or special paint designs that will appear on the vehicles you intend to use while performing security services.

**USE OF MULTIPLE VEHICLE DESIGNS**

You may use multiple vehicle designs, but you must submit each design for review and receive approval before using it. A new vehicle design must be submitted for any non-identical set of verbiage, font, decal, and/or special paint design. Once a design has been approved, it can be used on any vehicle, regardless of the make and model of the vehicle.

**VEHICLE PROHIBITIONS PURSUANT TO DRMC 42-135(a)(2)**

It shall be unlawful for any person, while providing or performing security services within the city, to use or operate any vehicle displaying the words "police" or "officer," or displaying any sign, shield, marking, or insignia that indicates or implies that the vehicle is operated by a law enforcement agency.

**NOTICE OF AUTHORIZATION**

A licensee shall not authorize the use of vehicles during the performance of security services without first receiving a vehicle endorsement from the Department.

**After acceptance of this vehicle design, any subsequent changes to the vehicle design must be submitted for approval before being used.**
