




## South Central Transportation Network Newsletter

**We are thankful for you, Denver!** As we continue to expand and grow our bicycle network, we want to say thank you for the time you've dedicated to engaging in this process. We are proud to build a bicycle network that incorporates the needs and feedback of the community into how we design bikeways. To date, we've offered nearly **150 office hours sessions** where community members can meet directly with city planners, received over **3,400 responses to our community surveys**, and have connected with over **1,300 community members** at virtual open houses and stakeholder working group meetings. We couldn't do any of this without your continued involvement. Thank you!

In this month's newsletter, we're unveiling a new animated video that explains what a Neighborhood Bikeway is and how this design makes it safer to bike on Denver's streets. **So, what exactly is a Neighborhood Bikeway anyway?**



You can be one of the first to see DOTI's new animated Neighborhood Bikeway video that shows how our bikeways are making it safer to travel on Denver streets no matter if you choose to drive, bike, walk, or scoot. Neighborhood Bikeways incorporate roadway design, signage, and traffic calming measures to create low-stress, low-volume streets that are safe for all users. This type of bikeway is sometimes referred to as a bicycle boulevard or shared street, but Neighborhood Bikeway is the official name in Denver! ### **Colorado Lawmakers Prioritizing Bicycle Safety**

There are several policies and changes on the horizon to improve bicycle safety as Denver expands its bike network. First is a measure that pushes for [Denver residential speed limits to be reduced from 25 mph to 20 mph](#), and second, CDOT is installing new signage to promote the "[Three-Foot law](#)", which requires a 3-foot passing distance between motorized vehicles and bicyclists to avoid sideswiping them or causing bicyclists to overcorrect to avoid a vehicle. Another topic for discussion is the [Colorado Safety Stop](#) bill that allows bicyclists to legally roll through stop signs. Follow the links to learn more about these upcoming measures.
