**Additional or Existing Address Entrance Requirements**

<b>Authority:</b>	Revised Municipal Code, Chapter 49, Article IV
<b>Purpose:</b>	The City Engineer or designee has the authority to assign addresses within the boundaries of the City & County of Denver per Sec. 49-56 (Code 1950 341.2) of the Denver Revised Municipal Code (DRMC) and per the Engineering Addressing Policy dated 02/01/2010.
<b>Document Date:</b>	6/11/2021
<b>Address Date:</b>	Additional or existing addresses issued for commercial, residential or other types are in effect until: <ul style="list-style-type: none"> <li>• The building has been demolished</li> <li>• Permits were not approved</li> <li>• The owner requests a change of address that conforms with addressing standards</li> </ul>
<b>Request:</b>	The request for an additional address shall be made before logging in for permits or as a requirement for permit purposes. Zoning approval may be required before purchasing the additional address(es).

<b>Submittal Requirements:</b>	<b>Additional or Existing Address:</b> Applicant must furnish a site plan and/or plot plan. Include survey if the property boundary will change. All plans shall include the north arrow, surrounding streets designations and location of the structure with respect to the property lines. Mark the front door with an 'X' to indicate the entrance. <ul style="list-style-type: none"> <li>• <i>Some additional or existing addresses may require zoning approval prior to address issuance</i></li> </ul>
<b>Fees:</b>	\$50 per address and/or \$50 per unit.
