Subject: Proposed Change to the Classification and Pay Plan

The proposed change amends the Classification and Pay Plan by changing the pay grades of: Associate City Planner from 808-E to 809-E, Development and Planning Supervisor from 812-E to 813-E, Principal City Planner from 812-E to 813-E and Senior City Planner from 810-E to 811-E.

In the last five years, CSA has done major studies on the Planner classes, the Landscape Architect classes, and the Engineer classes as well as creating the Project Manager classes. The Planner Study was the first of these studies. At that time, the Planner classes were assigned pay grades based on market data. As the other studies were conducted, pay was established using market data and internal equity. What has occurred is the other classes have moved up and the Planner classes were left behind. This is said with the understanding that in the city, there is a systematic way of doing work that includes planning, design, and construction. Therefore, the pay of the planner classes needs to be evaluated in relationship with other classes in design and construction.
