This application allows cabaret licensees to apply for an underage patron license to allow patrons 16 years of age and older to gain entry into and participate in standard, dance, special dance, acoustic, or event center cabaret licensed establishments.

The following questions must be answered. Any false answer or statement made constitutes perjury and subjects the license issued herein to suspension or revocation. ALL ANSWERS MUST BE PRINTED IN INK OR TYPEWRITTEN.

Within the past two years, has the applicant or any manager, agent, or employee of the applicant sold, served, distributed or allowed the purchase or delivery of alcohol beverages to any person under the age of twenty-one years? If yes, please explain in detail. Attach additional sheets if necessary.

2. During the past two years, has the Denver Public Nuisance Abatement Coordinator issued a public nuisance abatement plan to the applicant, applicant's landlord, or the property on which the premises are located? If yes, please explain in detail. Attach additional sheets if necessary.

If the applicant answered "no" to both questions 1 and 2 above, please provide:

- (A) A summary sheet and general description of how the applicant's employees and/or agents will prevent underage patrons from purchasing, possessing, consuming and/or removing from the licensed premises any alcohol beverage originating from the licensed premises if this application is approved; and
- (B) A complete and chronological description of your training, experience and record in managing liquor and cabaret licensed facilities with all legal requirements.

If the applicant answered "yes" to question 1, question 2, or both, please provide:

- (A) A detailed summary sheet and detailed written operations plan of how the applicant's employees and/or agents will prevent underage patrons from purchasing, possessing, consuming and/or removing from the licensed premises any alcohol beverage originating from the licensed premises if this application is approved and evidence of sufficient personnel, training, and equipment resources to carry out the operations plan;
- (B) A complete and chronological description of your training, experience and record in managing liquor and cabaret licensed facilities in compliance with all legal requirements; and
- (C) A copy of the applicant's employee training manual and/or employee policy and procedures manual which describes the various employee assignments, duties and responsibilities in guest relations, alcohol sales and service, and the prevention of underage patrons from purchasing, possessing, consuming or removing from the licensed premises, any alcohol beverage originating from the licensed premises.
- (D) Evidence of the prior approval by the Building Inspection Division and Denver Fire Department of a diagram of the proposed licensed premises that details the physical layout and the configuration of assembly areas during all operations including emergency exits, emergency lighting, and changes upon occupancy loads during the proposed cabaret operations.
