2025 Campaign Finance Reporting Calendar

Candidate committees, political action committees (PACs), and small donor committees (SDCs). Committees file semiannual reports in the second year of the election cycle. See *D.R.M.C. § 15-35(b)*.

Note: The next regularly scheduled general municipal election will be held on April 6, 2027.

Issue committees. Once an issue committee is formed, it must file regular reports. See *D.R.M.C. § 15-35(c)*. Issue committees must terminate no later than one year from the date of the election at which a ballot issue is voted on. See *D.R.M.C. § 15-34(h)*.

Note: The next general election will be held on November 5, 2025.

Please Note:

Major Contributions. The committee shall file a report if the committee receives any contribution or contribution in-kind of \$500 or more within the six (6) days immediately before the election. Such report shall be filed no later than 48 hours after receipt. *D.R.M.C. Article III, § 15-35(f)*.

***Office Closures.** If a reporting day falls on a weekend, legal holiday, or a City and County of Denver furlough day, the report shall be filed by the next business day. If a reporting day falls on a day when the city is fully or partially closed for business, then the report shall be filed in accordance with any and all rules or policies designated by the clerk and recorder. See *D.R.M.C. § 15-35(i)*.

This provision does not apply to Major Contributor, Independent Expenditure, and Electioneering Communication Reports. See *D.R.M.C. §§ 15-35(f) and 15-35.5(a)*.

Reports must be filed no later than 11:59 p.m. MT on the due date to be considered a timely submission. See *D.R.M.C. § 15-36(b)*.

Committee Responsibility. Legal provisions are subject to amendment from time to time. Therefore, it is incumbent on a person to determine if any new legislation or rules have been enacted.
