

EXECUTIVE ORDER NO. 140

TO: All Agencies Under the Mayor

SUBJECT: Use of Alternate Titles by Appointed Charter Officers

Purpose: The purpose of this Executive Order is to implement a portion of referred charter amendment 2B, as approved by Denver voters on November 5, 2013. Traditionally the charter has used the title "manager" to describe officer in charge of the departments under the Mayor, as set forth in Article II of the charter. Charter amendment 2B of 2013 added a new subsection 2.2.10 (D) which allows the Mayor to "order a different or additional title to be utilized by these officers for the purpose of standardizing and modernizing official titles consistent with best practices." Executive Order No. 140, dated March 1, 2015, is hereby canceled and superseded by this Executive Order No. 140.

- 1.0 **Applicable Authority.** The applicable authority relevant to the provisions and requirements of this Executive Order is found in § 2.2.10 (A) and (C) of the Charter of the City and County of Denver, as well as in the Mayor's authority to order different or additional titles for appointed charter officers as set forth in subsection 2.2.10 (D).
- 2.0 **Order to Use Alternate Titles.** I hereby order appointed charter officers to use the following alternate titles.

- 3.0 **Circumstances Under Which Alternative Titles Shall Be Used.** Appointed charter officers shall use the alternate title set forth in section 2.0 when executing any document in their official capacity including:

Contracts and other legal instruments
Internal and external correspondence
Rules, regulations and policies, including execution of future executive orders
Any order or ruling for which an action by the charter officer is required
Any oath or affirmation, including the oath of office

4.0 Letterhead, Business Cards, Electronic Communications, and Other Written Materials.


The alternate titles set forth in Section 2.0 shall also be used upon any departmental letterhead, business cards, electronic communications (including e-mails and web pages), and other written material identifying the office and the officer; provided, however, that nothing in this Order shall require any Department to reprint or reproduce any existing written materials previously printed by the City if to do so would add any additional costs to the City. Appointed charter officers will exhaust any present supplies of printed materials such as stationery and business cards reflecting the old charter title before printing new materials reflecting the alternate title.

5.0 Alternate Titles Legally Equivalent to Charter Titles.

Whenever any charter officer executes any document or takes any other official action using the alternate title set forth in Section 2.0, the act shall have the same legal force and effect as if the officer had executed the document or taken the official action using the traditional charter title.
