If you were not paid at least the minimum wage or you were not paid the wages you earned, contact us today.

Are you paid at least the minimum wage?

\$18.81 per hour in 2025.

It applies to all work performed in Denver with few exceptions.

你是否至少按最低工资获取报酬？

2025 年最低工资为每小时 \$18.81 美元。

这一规定适用于 Denver 所有工作岗位，仅有极少数例外情况。

Food and beverage industry may reduce pay based on actual tips received, up to \$3.02 per hour.

If you or someone you know earns less than Denver's minimum wage, you can submit a wage complaint to Denver Labor to initiate an investigation.

食品饮料行业可能根据员工实际收到的小费来降低其薪酬，最高降薪为每小时 \$3.02 美元。

如果你或你认识的人所得报酬低于 Denver 的最低工资金额，你可向 Denver 劳动部门提交工资投诉，以便启动调查。

Denver's minimum wage and civil wage theft ordinances protect all who work in the City and County of Denver, regardless of immigration status. Wage theft includes promised wages and other benefits.

Wage theft is illegal. Retaliation is illegal. Denver Labor is here to help.

Denver 最低工资和公民工资盗窃条例保护在 Denver 市和 Denver 县工作的所有人，无论其移民身份如何。工资盗窃包括承诺的工资和其他福利。

工资盗窃属于非法行为。报复是非法行为。Denver 劳动部门随时为你提供帮助。
